You have the right to cancel this contract within 14 days without giving any reason; unless the terms are made to your specification or clearly personalised – such as made to measure or bespoke goods or, in the case of a saddle, bridle or harness are made to template/measure for a specified horse/pony, where you then have no right to cancel this contract. Where applicable our fitting service is subject to a consultation fee and mileage allowance which is not refundable as it is a cost incurred for services rendered at the time of our visit. The cancellation period will expire after 14 days from the day after the day on which you acquire, or a third party other than the carrier and indicated by you acquires, physical possession of the goods or in the case of multiple goods the last good.

We will inform you of the delivery date. Where a new saddle is being ordered we may have to contact the saddle manufacturer before agreeing a delivery date.

To exercise the right to cancel you must inform us of your decision to cancel this contract by a clear written statement (e.g. a letter sent by post, email or fax where applicable). You may use the attached model cancellation form, but it is not obligatory. To meet the cancellation deadline, it is sufficient for you to send your communication concerning your exercise of the right to cancel before the cancellation period has expired. If cancellation is required, 20% of the total fee will be retained as a usage fee.
